Cllr Curwen also declared an interest in the planning application for 1 Duddon Mews.

Cllr Longworth declared an interest in item 8 – Land at Foxfield.

5. The Council were reminded that a resident does not wish to have a street light on her house.
6. Concern was raised from several members of the public regarding the planning application for a car park.
7. The public are concerned at public participation being near the beginning of the meeting, they would prefer it to be near the end.

107/10 Land at Foxfield
