Concern was raised about the sign at the top of Griffin Street which is in the middle of the pavement and wheelchairs and pushchairs cannot get past.

Concern was raised regarding the new speedbumps.

There was a request from Broughton in Bloom to hang to hanging baskets on the bus stop. The council had no objections to this.

Concern was raised regarding the LDNPA allocations of land – issues and options document which a member of the public had a copy. The clerk had not received a copy and will conact LDNPA regarding this matter

#### **092/10 Brown Cow Charity**

There was a discussion regarding the charities funds going into the Wilson Park account. The Council agreed that the Wilson Park accounts only holds charity funds and that this account should not be included in our Annual Return.

The council have not nominated one councillor to attend the Victory Hall Committee Meetings.

The council were advised that were had begun on the solar panels.

#### **095/10 Children's Playground**

Cllr Albion gave an update on the recent playground inspection.

Cllr Albion and the Clerk were tasked with getting quotes for the necessary work which needs to be done.

Cllr Albion advised that it would cost about £40.50 to have a sign made and the council agreed for the sign to be made.

**Resolved** that a new bin be fitted in the playground area.

#### **096/10 Brackenfield, Foxfield**

There was discussion regarding a letter the clerk had received regarding the land rented out at Brackenfield.

**Resolved** that the agreement continue in the short term but the council will be reviewing land they own in the near future and will consider reviewing the situation.

#### **097/10 Benches**

The clerk advised that SLDC had given quotes for the repair of the benches but she had also been advised that the rivots were rotten and there was no guarantee the benches would last even after repair work.

The council were in agreement that a second opinion should be sought.

#### **098/10 Councillors Reports**

Cllr Longworth advised that she would be attending a meeting with the police and the LDNPA Warden on Anti Social behavior and parking and asked if there were any issues the council would like brought up.

There were a number of suggestions including, rubbish, Poaching and diesel theft.

Cllr Longworth also raised concern about the parish councils posters being set on fire.  
Cllr Barker requested that Allotment rent on the income and expenditure statement be changed to Land rent.

Cllr Barker also requested that street lights be put on the next agenda and that the clerk write to United Utilities to find out where the electric supply is.

Cllr Curwen advised that the trees at Orchard Head need to be cut back. He also advised that he would be attending a meeting regarding the Duddon Estuary.

Cllr Curwen he had attended a Community Liaison meeting where problems in rural areas will be highlighted.

Cllr Curwen also advised that some drains in the area had been flushed out.
