## 03/16 Declaration of Interests

Cllr Knowles and Cllr Burch declared an interest in item no: 15 - Parish Lengths man.

#### 04/16 Minutes

# 05/16 Public Participation.

- a) Police were not in attendance but had sent a report to the clerk advising that CGP Pitstop had been broken into and enquiries are ongoing and also drivers are not realising that Wreaks Level stops been straight at each end.
- b) County Cllr David Fletcher was not in attendance.
- c) Public- Want to know what happens to the money from sale of Broughton assets? Concern was raised about flooding, fire brigade had been called what's happening with drains? Concern was raised about sewage coming into a garden through drains, Sandbags were coming from Ulverston but somewhere to store them is needed. Broughton-in-Bloom asked if the planters in the square could be made to match other planters. Concern was raised about the state of a bench which needs repainting. Wanted to know if the tree in the square is to be pruned and suggested cycle racks, which will be put on the next agenda.

B Johnson was in attendance and suggested the possibility of using the top yard at the Auction Mart as a car park. The Auction Mart would not take any money or run it but would charge rent.

- **b)** Bench outside Information Centre Resolved that Cllr Albion will repaint the bench it is expected that the cost will be about £20.

Duddon Parish Council held an Extra Ordinary meeting on 18 December 2015 to discuss this matter and Resolved to support the retention of a Post Office Facility in Broughton-in-Furness. **b) Donations Update – Resolved** to note that donations to date for the Post Office total £1, 17.53 an initial £250 will pay for a professionally drawn up business plan.
