132/19 Apologies

Resolved to accept apologies from Cllr C J Jardine, Cllr G Pitts and C Adams (Clerk).

133/19 Requests for Dispensations

134/19 Declaration of Interests

Cllr Knowles declared an interest in item 11 Victory Hall and also item 17 Parish Lengths Man

136/19 Minutes

Resolved that the minutes of the meeting held on Thursday 23rd May 2019 be signed by the chair as a true record.

137/19 Chairs Announcements

The chair advised that the Charge My Street launch has been rearranged for 5TH July 2019. The chair also advised that she had sent a thank you card to J Johnson. She also advised that in future the draft minutes will be sent to the chair and the vice chair for the comments before then being sent to the rest of the Council for any amendments to be sent to the clerk. Final draft will be sent out with the agendas.

138/19 Public Participation.

- a) Police were not in attendance but had sent an email advising they would not be in attendance for a few month.
- b) The County Cllr was in attendance gave an update on the 20mph speed limit for Broughton and advised a further meeting regarding this will be on 23rd or 24th. Got funding for the scheme at last. Work at Wreaks Level is about to conclude. He is still trying to get the road in front of the Victory Hall resurfaced. CCC are coming to sort out the white lines at Wreaks End. The signs in Church Street will be changed so that vehicles leaving Broughton will have priority. Cllr Brereton has had a meeting with Copeland regarding the sight lines at Duddon Bridge and repairs.
- c) District Cllr I Wahrton was in attendance and advised he will on the LDNA Planning Committee and also on the licensing committee
- d) Public – The chair of the Community Led Plan Steering Group was in attendance and reported that they are fund raising. She also advised that they are waiting for the police to agree to the positioning of the SID but to date there are no costs yet for the estimated costs of repairs and maintenance of the SID.
