Resolved to accept apologies from Cllr C Edmondson, Cllr J Johnson, Cllr G Pitts and Cllr J Saver.

The Chair took this opportunity to remind everyone about the code of conduct in particular treating others with respect.

211/17 Public Participation.

a) Police were not in attendance but had sent an e-mail to the clerk advising:-

There had been an enquiry from Dorsett police at Satterthwaite about a burnt out car, empty property at Satterthwaite so believed to be an insurance scam- Criminals buy a car don't register it and purchase insurance for a fictitious person at a real address where insurance is cheap.

Ongoing neighbor/boundary at Bank End.

Usual section of livestock on the roads and drivers attempting to make their vehicle occupy the same space as another vehicle at the same time.

Suitable spots for signage for the No Cold Calling Zone in Church Street have been located and need to map this and forward to trading Standards for Registration. Aiming for a launch date in the New Year.

b) County Cllr Matt Brereton was not in attendance but had also sent an e-mail advising that he will keep pushing for all the things that were promised in the walk around. He has been told that Highways are on course to complete this by Christmas. He has been closely advising the speed action group on possible next steps and has a commitment from Victoria Upton for a meeting in the New Year to discuss possible options. The 30mph light up signs at Foxfield are apparently "at the end of their life cycle" but he will continue to push for the one that remains in place to be repaired.

Constituted groups and Parish Councils can apply for a Local Community Grant as long as they have a worthwhile project of Capital Improvements and at least one other source of income

d) Public were in attendance and asked if the Parish Cllr would be represented at the meeting at Coronation Hall in Ulverston regarding the Kirkby Windfarm planning.
