Minutes of the meeting held on Thursday 28 September 2017 in the Rankin Room Victory Hall, Broughton-in-Furness

- 169/17 Apologies

The Chair told everyone that the meeting is to move on swiftly and calmly with 1 person speaking at a time.

- 176/17 Public Participation.
 - a) Police were in attendance and reported to incidents as follows:
 - i) A dispute over tarmac
 - ii) A Cow on the road at Broughton Beck

The date for the no cold calling zone knock on door/letter drop is 23 October 2017.

b) County Cllr Matt Brereton was in attendance and has been very active since the last meeting including a local area committee meeting and a meeting with Victoria Upton. The agreed work from the walk around in Broughton should be done by Christmas. There is no news yet on the double yellow lines at New Street. Talked about local impact traffic calming to tackle Station Road being used as a rat run within a rat run. Duddon Bridge has been reported to the structures team. Cumbria County Council are working with SLDC regarding the weed killing but nothing will be happening this year. County Cllr Brereton is happy to be contacted preferably by e-mail but will respond at

the next Parish Council meeting. If he cannot attend a meeting he will send a report via the clerk. He will also support the new Community Group that will be running the Information Centre and also will support the Community Led Plan steering Group.

- c) The Chair of the Community Led Plan Steering Group thanked the police for putting SID in Church Street. The data has been shared with the County Cllr and Victoria Upton. 2700 vehicles now coming through Broughton. A few are speeding. A manual count was done when the local road was closed and 137 vehicles instead of 300 came through at one particular time. The chair intends to write to to BT regarding the 34 new poles and will also be writing to SLDC regarding the planning application for the Kirkby Moor Windfarm. There is no further news regarding Ulverston Post Office. The chair will be talking to J Woodcock regarding Broughton Post Office ahead of the annual review. The table tennis club is doing well and it is intended to start a table tennis club for adults. The chair will be putting an update in the Parish Pump regarding Highways.
- d) Public Concern was raised about the state of the black door at the bottom of Kepplewray Hill. Concern was also raised about the rhododendrons on Kepplewray Hill. They need a really good cut back.

A resident from Church Street advised that Church Street was glorious when the local road was shut. He was pleased to hear talk of possible traffic calming measures. The early morning traffic does not stop to shop in Broughton.

There was a suggestion that a speed camera would help to resolve the traffic issues.

177/17 Trees in the Square

There was a discussion regarding the report from B Hatton regarding the trees in the Square. **Resolved** that 3 Quotes will be sought to have the recommended work done.

178/17 Wilson Park

Cllr Downe reported that she had contacted B Johnson for an update on the possibility of the Auction Mart being used for public parking. The answer was that this is no longer an option but did not elaborate on that. Cllr Downe suggested that a small area of Wilson Park (on the right as you go in) could be used a car parking area and Cllr Curwen suggested that the top of Wilson Park could be used for car parking for CGP workers but they would have to enter via the Tower Drive.

Resolved that the clerk will try to find out who owns the lane between the Square and the gate at Wilson Park.

There is to be a sale of goods that are stored beneath the stage at the Victory Hall. If anyone wants to go and price things up they are very welcome alternatively Jenny will just price everything. The proceeds go towards the Victory Hall.
